## May AICP Exam Postponed

According to Felicia Braunstein, Professional Practice Director, APA, the May AICP Certification Exam will not occur in May. See the message from Ms. Braunstein below.

Certification Exam, you are probably very anxious for news about expectations, and we appreciate your patience. We have been working with our exam testing partner, Prometric, to adjust the May exam testing window, since we know that testing centers are not open, and the timeline for returning to routine testing operations is unknown at this time.

As a result, we want to confirm that the next AICP Certification Exam will not occur in May. While we rely on Prometric for information about their resources and availability, we are also actively exploring possibilities for an expanded testing window with new exam dates this summer, including potential alternative testing options such as remote online testing. Our priority is to support your professional development goals with as much flexibility and creativity as possible. Rest assured that we will share additional information with you as soon as it becomes available, so that you can plan accordingly and put your best efforts into the exam process.

Thank you very much for your understanding as we do our best to navigate uncertain times with our testing partners.

We are here for you, and hope this update allows you to devote your full attention now to the priorities that matter most- tending to the health and safety of yourselves, your loved ones, and your communities.
